Women, men, kids outerwear & homewear (pyjamas, shorts, T-shirts, nighties, sweatshirts, tracksuits) made of white, reactive and disperse dyed knitted fabrics made of 100% cotton, cotton/elastane, cotton/modal, cotton/modal/elastane, cotton/viscose (bamboo), cotton/polyester, 100% viscose, viscose/elastane, viscose/polyester, viscose/polyester/elastane, 100% modal, 100% polyester, polyester/elastane as well as pigment printed knitted fabrics made of 100% cotton, 100% viscose, 100% modal and with or without elastane, cotton/modal/elastane also pigment printed knitted fabrics made of cotton/modal, viscose/polyester/elastane, cotton/polyester/elastane and digital pigment printed knitted fabrics made of 100% cotton and viscose/elastane. Including accessories such as white and disperse dyed sewing yarn, elastic tapes of polyester/natural rubber in different colors, white and yarn dyed woven & knitted tapes, belts and cords with jacquard, dyed tulles and laces and yarn dyed woven labels made from 100% polyester.

The results of the inspection made according to STANDARD 100 by OEKO-TEX®, Annex 4, **product class II** have shown that the above mentioned goods meet the human-ecological requirements of the STANDARD 100 by OEKO-TEX® presently established in Annex 4 for products with direct contact to skin.

The certified articles fulfil requirements of Annex XVII of REACH (incl. the use of azo colourants, nickel release, etc.), the American requirement regarding total content of lead in children's articles (CPSIA; with the exception of accessories made from glass) and of the Chinese standard GB 18401:2010 (labelling requirements were not verified).

The holder of the certificate, who has issued a conformity declaration according to ISO 17050-1, is under an obligation to use the STANDARD 100 by OEKO-TEX® mark only in conjunction with products that conform with the sample initially tested. The conformity is verified by audits.
